WITH THE CONTINUALLY CHANGING GUIDELINES. IN CONCLUSION, OUR CAMP SURVEYS SHOWED POSITIVE STRIDES IN FRIENDSHIP-MAKING SKILLS, INDEPENDENCE,
KNOWLEDGE OF ONE'S OWN MEDICAL NEEDS AND RESTRICTIONS, AS WELL AS IMPROVED SELF-CONFIDENCE. THROUGH
OUR PROGRAMS, WE ARE SEEING OUR CAVETT KIDS GROW BEYOND THEIR DIAGNOSES. THEY ARE NOT JUST SURVIVING, THEY ARE THRIVING.
