



Cavett Kids wants to provide nothing but the safest environment for every child. Because children and youth chronic illnesses vary substantially, each child and their specific situation will be evaluated on a case-by-case basis in an effort to determine eligibility.

## General Camper Criteria

- Function independently without requiring continuous one-on-one supervision or attention.
- Have the mental capacity to interact acceptably with others. Any behavioral disorders or psychiatric diagnoses must be approved by staff prior to camp.
- Independently abide by any specific dietary needs noted on their registration forms.
- Personal skills of campers should include the ability to function independently for daily personal care (i.e., eating, drinking, bathing, dressing, and using the restroom).

## Camp Cavett Qualifications

*Camp Cavett campers must meet all of the General Camper Criteria as well as the following:*

- **Diagnosis:** Any life-threatening or chronic illness
- **Age:** 8 to 18 years-old and/or still attending high school
- **Medical Criteria:** Follow their medication schedule by going to the medical station as required
- **Other Considerations:** Frontier Cove is almost completely paved and is easily maneuverable. Most campers with physical limitations should have no problem at this camp. Campers must be able to pass a swim test in order to swim, but plenty of other activities will be available in addition to water-based activities. Many activities take place outdoors in the sun and heat, but air conditioned facilities and drinking water will be available throughout the camp. Dialysis will also be available at this camp.

## Discovery Qualifications

*Discovery campers must meet all the General Camper Criteria as well as the following:*

- **Diagnosis:** Any chronic or life-threatening illness
- **Age:** 8 to 12 years old
- **Medical Criteria:** Follow their medication schedule as instructed by camp medical volunteers
- **Other Considerations:** Camp Trivera in Oklahoma City is completely ADA accessible. Campers requiring dialysis during the camp session will be transported to the Oklahoma Children's Hospital dialysis unit.

## Connections

*Connections campers must meet all the General Camper Criteria as well as the following:*

- **Diagnosis:** Any chronic or life-threatening illness
- **Age:** 13 to 18 years-old and/or still attending high school
- **Medical Criteria:** Follow their medication schedule independently or with minor assistance.
- **Other Considerations:** Camp Trivera in Oklahoma City is completely ADA accessible. Campers requiring dialysis during the camp session will be transported to the Oklahoma Children's Hospital dialysis unit.

## Leadership Camp Qualifications

Leadership Camp campers must meet all of the General Camper Criteria as well as the following:

- **Diagnosis:** Any life-threatening or chronic illness
- **Age:** 13 to 18 years-old and/or still attending high school.
- **Medical Criteria:** Follow their medication schedule independently or with minor assistance.
- **Other Considerations:** Cross Point Camp is located on the shores of Lake Texoma. Walking paths throughout the camp are mostly gravel or sand. With this in mind, campers with physical limitations are welcome to attend this camp if they are comfortable on rough terrain. Golf cart transportation may not be available at all times.

## Beach Bash Qualifications

Beach Campers must meet all of the General Camper Criteria as well as the following:

- **Diagnosis:** Any chronic or life-threatening illness
- **Age:** 16 to 18 years-old and/or still attending high school
- **Medical Criteria:** Follow their medication schedule independently or with minor assistance.
- **Other considerations:** Parents and campers should keep in mind that this trip will include transportation via airplane and requires maneuvering independently through busy airports. Activities on this trip will involve maneuvering on beaches, boats, and boardwalks. In addition, most beach houses require climbing multiple sets of stairs. This trip is not recommended for non-swimmers, campers with severe mobility restrictions, or those with sensitivity to sunlight, saltwater, or other factors found in tropical environments.

## Mountain Madness Qualifications

Mountain Madness campers must meet all of the General Camper Criteria as well as the following:

- **Diagnosis:** Any chronic or life-threatening illness
- **Age:** 16 to 18 years-old and/or still attending high school
- **Medical Criteria:** Follow their medication schedule independently or with minor assistance.
- **Other Considerations:** Travel to Angel Fire involves a 9-10 hour bus or van ride. The physical environment in Angel Fire consists of mountainous, rocky terrain and high elevations. High adventure activities include ATV rides and a full day of white water rafting on the Rio Grande River. High-functioning physical mobility is highly recommended for this trip.
